What information do you need to provide?

In order to receive DUNS, you must provide the following information:

- company name;
- legal and actual address where the company is located;
- information about the owner of the company;
- form of organization;
- date of establishment of the institution;
- type of activity;
- number of company employees.

How long does it take to register?

As a rule, the registration procedure takes about 30 days from the moment the application is submitted and the details of cooperation are discussed with a representative of the institution.

Organizations located outside the United States must be registered in a special Dun&Bradstreet database. This is a kind of employer EIN number.

What does a unique identifier provide?
